The IRELAC, the EU-LAC Foundation and the IdA propose to dedicate an international seminar to the issues and challenges the Caribbean region is facing in the framework of the EU-CELAC partnership. The Caribbean space is affected in specific ways by several issues, among others, climate change, financial constraints, interconnectivity challenges, and the changes in the trade arrangements and regional cooperation with the EU as well as with its Latin American partners inside the new CELAC scheme. The new Caribbean-EU Joint Strategy and the EU-CELAC Action Plan intersect at several points, while the region's specific conditions necessitate a reflection process on how to fully involve the Caribbean in the bi-regional association. The main purpose of the seminar is thus to open a space for a free exchange of views between academic experts and official authorities in order to contribute to spurring the momentum reached at the Santiago Summit to improve the Caribbean's involvement in the implementation of the Santiago Action Plan and fostering its full integration both in CELAC and in the EU bi-regional cooperation. The EU-Caribbean cooperation policy is still dispersed and in some ways incoherent with European as well as Caribbean intentions of associating the region more closely to the Latin American and Caribbean space, expressed at the EU-LAC Summits and in the growing inclusion of the Caribbean into the CELAC dynamics. It is all the more important to adapt the EU instruments that the Joint Caribbean-EU Partnership Strategy plans to establish a structured framework for broader and deeper political dialogue. Topics of intersection between the Caribbean-EU Joint Strategy, the EU-CELAC Action Plan, and the EU-LAC process more generally deserve particular attention. The goal of this seminar is thus threefold:

- Identify synergies between the Caribbean-EU Joint Strategy and the EU-CELAC Action Plan
- Analyse the specific situation of the Caribbean within the EU-CELAC partnership with a view to enhance its participation in it.
- Reflect upon aspects of interconnectivity in the Caribbean within the EU-CELAC setting.

Based on these reflections, the seminar conclusions should allow the identification of first operative steps to be taken to further integration of the Caribbean in the bi-regional partnership.
